WHEREAS, the Howland Township Trustees met in regular session, pursuant to notice, on July 14, 2010 at 6:00 P.M. at the Howland Township Administration Building, 205 Niles-Cortland Road N.E., Warren, Ohio, 44484, with the following members present:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF HOWLAND TOWNSHIP, COUNTY OF TRUMBULL, OHIO THAT:

Section 1: It is hereby authorized that the Law Firm of Charles L Richards shall be hired as Law Director for Howland Township.

Section 2: It is further authorized that the Howland Township Board of Trustees will enter into a formal contract with the Law Firm of Charles L Richards which will continue

from July 1, 2010 through June 30, 2011, and will be retroactive to April 1, 2009. A copy

of the legal services contract is attached hereto as Exhibit A.

Section 3: Under the legal services contract, the Law Firm of Charles L Richards shall be compensated in the amount of \$2,500 per month, not to exceed \$30,000 annually, for general legal services, exclusive of costs and fees for any litigation pending in any state or federal court, for which litigation Mr. Richards' law firm shall be paid that hourly rate which Mr. Richards' firm is usually and customarily paid as litigation counsel in such matters.

Section 4: It is further agreed to and so stated in the legal services contract that Howland Township and/or the Law Firm of Charles L Richards shall have the right to terminate the contract between them upon providing the other party written notice of its intention to terminate at least thirty (30) days prior to termination.
