Summary of Meeting:

Tom Harwood, Chairperson of the Trumbull County Transit Levy: In 2003 made three to four thousand trips a year. Today it makes 80,000 trips per year. Trumbull County had provided \$1.2 million and they no longer will be funding the transit. Only funding is from the Senior Levy of \$460,000. Thirty-one thousand seniors and 36,000 handicapped/disabled are provided transportation.

Public Works Director David McCann: Doing catch basin repairs and skim coating. Was delayed in September due to rain. Limb and Branch pick-up will begin on the eastside October 24th. Henn Hyde paving project will begin within the next 2 weeks.

Planning & Zoning Director Kim Mascarella: attended Land Bank Seminar in Cleveland today.

Resident George Holko: Interested in setting up a civilian police academy for the residents. Police Chief Monroe stated that a "community block watch" would work better but no one has shown much interest.

Donna Gates, 1371 Castillion: concerned about drainage ditch beside house. Water sets in backyard. McCann stated that current Issue II projects will not alleviate the water problem since it is wetlands. Trustee Clark suggested that McCann have URS look at the situation and see if anything be done. Tom Holloway of MVSD stated that because of Mosquito Creek water level being high there is nowhere for the water to runoff.

Fire Chief James Pantalone gave his annual report.

Resident George Holko asked why you have to pay for CPR classes. Chief Pantalone stated that the charge covers the books, ID cards and instructors who do the training. Really do not profit from the charge for the class.
