Currently interviewing for a firefighter/paramedic opening that is available.

The Howland Training Center will start a new class at Warren Township's Fire Station 49 on Monday. This takes the training center out of the main station where there is a lot of traffic.

Trustee Vansuch: Hometown Urgent Care moved in at the Boston Manor building and the Fire Dept Inspection Bureau was very helpful in getting them opened.

Public Works Director David McCann: The mild weather has allowed for the Public Works Department to do storm sewer projects, cleanout ditches and repairs to catchbasins.

Last year at this time the Township ordered 1700 tons of salt and this year we have ordered 550 tons of salt. This is a savings of almost \$70,000.

Christmas tree pick-up is currently in progress and will continue through January 13th. There has been a substantial amount of trees this year.

Robert Tucker (Resident and Alt on Zoning Commissoin), 314 Westchester Drive: congratulated elected Trustee Rick Clark, appointed Trustee James Saker and Sal Ciferno going from alternate on the Zoning Commission as full-time. Stated that the Township is well run.
