WHEREAS, there is not a single, permanent place where this story can be told; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Howland Township, Trumbull County, Ohio, that the Howland Township History Center be established to accomplish these goals; that the Administrator dedicate appropriate facilities within the Administration Building for these purposes, and that the Administrator, on behalf of the Board, accept and recognize donations to the Howland

Township History Center.

Honor Howland Township's bicentennial and declaring February 1, 2012 to be the official day of commemoration:

WHEREAS, on January 31, 1798, Joseph Howland bought a tract of land from the Connecticut Land Company in the area of Connecticut Western Reserve that later became Trumbull County; and

WHEREAS, Howland sold 1,600 acres of his land to Captain John H. Adgate and, in 1799, Adgate and his family arrived in the southwestern part of that area, building the Township's first log cabin; and

WHEREAS, more settlers followed and, in 1812, the Commissioners of Trumbull County organized the Range 3, Town 4 into a separate Township and election district, to be known as Howland Township; and

WHEREAS, the early records of that organization and its first officers have been lost; and

WHEREAS, in 1998, the General Assembly enacted legislation designating the first day of every February as "Ohio Township"; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Howland Township, Trumbull County, Ohio, that February 1, 2012 is designated as the day of commemoration for the bicentennial of Howland Township's official organization as a township and that all residents be encouraged to recognize and celebrate two hundred years of success.

At the July 4<sup>th</sup> celebration, the theme will be based on the bicentennial.

Resident Ray Zeuner, 8531 Red Oak: Happy to live in Howland. Glad that Board is looking at a bike path. Wanted to know if police vehicles could be powered with natural gas. Police Chief Monroe stated that it would not be cost effective.

Planning & Zoning Director Kim Mascarella: Zoning Board of Appeals approved a variance for IRG who is leasing the space to BJ Allen Fireworks. They will employ 250.
