WHEREAS, the Board of Trustees of Howland Township, approve the following resolution determining to proceed with the submission to the electors of Howland Township of the question of levying a tax, pursuant to Section 5705.19 of the Revised Code;

WHEREAS that the County Auditor has certified to the Board that the dollar amount of revenue that would be generated by 1.0 mills for each one dollar of total current tax valuation of this Township is the annual amount of \$466,122, which amounts to \$.10 for each one hundred dollars of said valuation.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Howland Township, Trumbull County, Ohio at least two-thirds of all members elected thereto concurring, being Resolution No. 2012-91, that this Board determines to proceed with the submission to the electors at an election to be held on November 6, 2012, pursuant to Ohio Revised Code 5705.03, 5705.19(J) and 5705.192,of the question of levying a replacement tax in excess of the ten mill limitation, providing and maintaining motor vehicles, communications and other equipment used directly in the operation of a police department, or the payment of salaries of permanent police personnel, including the

payment of the policemen employer's contribution required under Section §742.33 of the Revised Code, or the payment of costs incurred by townships as a result of contracts made with other political subdivisions in order to obtain police protection, or to provide ambulance or emergency medical services operated by a police department at a rate not exceeding 1.0 mills for each one dollar of valuation, which rate is the same as the rate of the existing continuous which is being hereby replaced (year of origin 1987), and which amounts to \$.10 for each hundred dollars of valuation for a continuous period of time commencing in 2012, first due in calendar year 2013. NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Howland Township, Trumbull County, Ohio at least two-thirds of all members elected thereto concurring, being Resolution No. 2012-92, that this Board determines to proceed with the submission to the electors at an election to be held on November 6, 2012, pursuant to Ohio Revised Code 5705.03, 5705.19(J) and 5705.192, of the question of levying a replacement tax in excess of the ten mill limitation, providing and maintaining motor vehicles, communications and other equipment used directly in the operation of a police department, or the payment of salaries of permanent police personnel required under §742.33 of the Revised Code, at a rate not exceeding .75 mills for each one dollar of valuation which rate is a reduction, by equal amounts, of two existing .50 mill Police Levies which are hereby combined into one replacement Police Levy of .75, and which amounts to \$.075 for each one hundred dollars of valuation for a continuous period of time commencing in 2012, first due in calendar year 2013. WHEREAS that the County Auditor has certified to the Board that the dollar amount of revenue that would be generated by 1.75 mills for each one dollar of total current tax valuation of this Township is the annual amount of \$830,612, which amounts to \$.175 for each one hundred dollars of said valuation.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Howland Township, Trumbull County, Ohio at least two-thirds of all members elected thereto concurring, being Resolution No. 2012-93, that this Board determines to proceed with the submission to the electors at an election to be held on November 6, 2012, pursuant to Ohio Revised Code 5705.03, 5705.19(I) and 5705.192, providing and maintaining fire apparatus, appliances, buildings or sites therefor, or sources of water supply and materials therefor, or the payment of permanent, part-time or volunteer firemen or firefighting companies to operate the same, at a rate not exceeding 1.75 mills for each one dollar of valuation, which rate is a reduction of two existing one mil Fire Levies (year of origin 1976 and 1977) both equally reduced and combined into one 1.75 continuous fire levy, and which amounts to \$.175 for each one hundred dollars of valuation for a continuous period of time commencing in 2012, first due in calendar year 2013.
