Summary of Meeting:

John Allison, Manager of Howland SCOPE Center and Ralph Smith, Director of SCOPE, presented concerns over the floor condition at the Howland Center. They stated that exposed boards are subject to further deterioration that may cause a safety issue. Major areas of the wood floor are lacking varnish in the high traffic areas. Three estimates were presented for sanding, staining and applying three coats of polyurethane (copy attached of estimates). Trustees asked if they would be willing to work out a cooperative matching agreement.

Director Smith said that if the Trustees propose a cost sharing plan, he would make the effort to find funding. Trustee Clark stated that they would examine the floor and make an informed decision in the future.

Trustee Clark: Workers Compensation liability is a savings of \$41,101 from last year's liability.

Townships are going to receive \$3,822.63 from local government and also receive \$121 per Township road miles which will amount to \$9,720 and will be receipted into the General Fund.

Fire Chief Pantalone: The Fire Dept. had about 100 more runs this year than in 2013.

Police Chief Paul Monroe: Thanked Trustees for maintaining staff and hiring Carmen Altobelli as a full-time patrolman. There is one more vacant position that needs filled. Looking at hiring in about 9 months once the budget is reviewed and by applying for grants.

Public Works Director McCann: Winter has been fairly slow. Normally use around 1,200 tons of salt. So far we have only purchased 680 tons from the County.

Planning Director Mascarella: 194 permits issued and the total value of is under \$7.8 million.
