Summary of Meeting:

Fire Chief James Pantalone: Had a successful smoke detector give away on April 5th. Visited 112 residences, distributed 28 smoke detectors and installed 23 batteries.

Trustee Lapolla: Wellness Committee is trying to have monthly outdoor activities. Met with the safety forces at the Park. Thanked Asst. Police Chief Nick Roberts and Trustee Vansuch and his family for being there. This month there will be another outdoor activity featuring the boardwalk and river walk program in order to bring it to people's attention.

Zoning Administrator Kim Mascarella: Howland Farmers Market is this Saturday. This is the last monthly market. The regular season will start June 20th and will be weekly thereafter.

Trustee Vansuch: Revised letter that was sent to the House Committee and addressed it to the Senate Finance Committee and Ways and Means Committee about the TPP tax. School districts were saved from the house budget cut, but not townships. This could mean a \$700,00 cut to our township effective July 1. The Police Chief and Fire Chief will be making a presentation to the Financial Committee next Wednesday (may 20th) because the brunt of that will be falling on the Police and Fire Department. This letter will also be sent to the Township Association and also to the Senators.
