Summary of Meeting:

Trustee Vansuch: Thanked Fire Chief James Pantalone and his outside business "Pantalone Towing", Dr. James Lapolla and Leo's Restaurante, for sponsoring the t-shirts for the summer

recreation program. The Township had cutbacks this year and the t-shirts were not part of the expenditures. The Trustees do appreciate their donation.

Administrator Darlene St. George: Wanted to publicly thank all the department heads for doing a great job on July 4th celebration and Trey Bryarly who put the July 4th celebration together.

Public Works Director David McCann: During the last month got the streets ready for the July 4th activities. Have had several areas in the Township that had storm damage. Picked up limb and branches. Also, making catch basin repairs. This week starting our crack and seal program.

Zoning Director Mascarella: The "Safe Routes to School" has been completed. Applied for the grant in 2013 and the improvements are on East Market Street, Brewster and Willow Drive. The grant was to make the area around Howland Middle School safer for pedestrian traffic and the children if they want to walk to school. The value of the federally funded program was \$400,000.

Farmers Market is going well. At the last market there were 28 vendors. The Township is starting a satellite farmers market once a month in the Bolindale neighborhood. It will be on July 21st from 3 PM to 6 PM at the Bolindale Park behind the fire station. This will continue in August, September and October, every third Thursday of the month

Administrator Darlene St. George: Want to thank publicly Bob Meinke from Creekside Gardens for the landscaping around the Howland signs at Routes 46 and 82. He donated all the plants and him time to improve the site.

Also, would like to thank the Public Works Dept. for installing an automatic watering system that will water the plants twice a day.

Audience – St. Mary and St. John, the Beloved Monastery at 8640 Squires Lane: The following residents voiced their concerns over a decision by the Township Zoning Appeals Board to allow a local the Monastery to construct a bell tower and mausoleum on the property. A variance was approved for St. Mary and St. John, the Beloved Monastery to build a 24,238 square foot church topped with a five-story bell tower and a 500 square feet mausoleum. Some concerns expressed included the height of the building, drainage of water into neighboring properties and lower property values.
