Summary of Meeting:

Fire Chief James Pantalone: The Fire Dept. will hold a Safety Day on October 1st at Home Depot. Friday, September 16th the Fire Dept. will reopen the Bolindale Fire Station. It will be open from 7 AM to 4 PM, seven days a week, with either 2 full-time employees or 2 part-time employees, or a combination of both.

Police Chief Paul Monroe: As of October 3rd, the Police Department will change the front desk office hours from 7:30 A.M. to 7:30 P.M. to 9 A.M. to 5 P.M. Part-time officers have been manning the desk. We have been monitoring the activity in the evening and it has been very light. This will result in a yearly savings of \$15,000.

Public Works Director David McCann: Finishing summer time work. Will start skim paving next week. The Township will utilize the County's tack truck. Limb and Branch pick-up has been scheduled and will begin in October. It is on the Township's web site and in the Tribune weekly.

Zoning Planning Director Kim Mascarella: There were six permits issued in 2015 for single family homes and Zoning has already issued 18 permits for 2016. A total permit valuation of \$7.4 million for this year compared to \$4 million in 205.

Robert Marino Sr., Niles, Ohio: Thanked the Trustees for approving the naming of the Howland Bridge as "Vietnam Veteran's Bridge". Mr. Marino was a Persian Gulf War veteran and veterans are very dear to him. All the veterans appreciate what the Trustees have done. There will be a dedication on October 29th at 10 A.M.
