The land contains environmentally sensitive habitats, approximately thirty (30) acres of wetlands, forest canopy, and 6,000 linear feet of stream channel. If the proposed project receives funding, the land would be preserved in perpetuity for the benefit of Howland Township, Warren City, Trumbull County and the businesses of the Golden Triangle Industrial Area. The project is a top tier project identified in the Golden Triangle Infrastructure Improvement Plan, and the project supports many goals of the Howland Township Comprehensive Community Plan adopted in 2010.
