WHEREAS, this request for funding reflects fifty percent (50%) of the total project cost in the amount of \$1,800,000 for the purpose of completing infrastructure improvements within the Golden Triangle Industrial Area including the Dietz Road Reconstruction Project and the Industrial Access Road Project identified in the Golden Triangle Infrastructure Improvement Plan, approved by the Howland Township Trustees on October 14, 2015 in partnership with the Board of Trumbull County Commissioners, the Trumbull County Engineer, and the City of Warren, and;
