## Summary of Meeting:

Police Chief Roberts: After the school shooting in Florida, I want to let Howland Township residents know that the Police Dept. is on top of things in Howland Schools. The schools are safe and we have safety plans in order and also have response plans in order. The Howland Police Dept. is here to protect our students and staff.

Public Works Director David McCann: Have been working diligently every day to repair pot holes. The truck that is used from cold mix and pot hole repairs had a breakdown this week, and will use one of the smaller dump trucks to continue until the engine is repaired.

Resident Ken Yarwick, 1459 Springwood Trace: Had question about the 11 acres that was sold and what might be going in. Zoning Director Kim Mascarella stated she would speak to him after the meeting.

Resident David Boyd, 2029 Silver Fox Lane: The fire truck that is being purchased, is it bigger than the current one. Are you sure that it will fit into your garage without having to do any modifications.

Fire Chief James Pantalone: The front axle has been engineered to fit. Measurements were taken before the order was placed.

Resident David Boyd, 2029 Silver Fox Lane: How was Mr. Tisone picked to be the hearing officer for the Civil Traffic Citations appeals?

Trustee Matthew Vansuch: Mr. Tisone is a retired attorney. He has knowledge and would competently handle the hearings. Atty. Tisone also handled the Township's dog ordinance in the past years. Also, he is not a business partner of mine.

Resident David Boyd, 2029 Silver Fox Lane: On the news it basically said that I can do whatever I want speed wise in Howland until March 6<sup>th</sup>. After March 6<sup>th</sup> if I am speeding, I could get a ticket between \$100 and \$150.

Police Chief Nick Roberts: Right now there is a 30 day warning period until March 6<sup>th</sup>. In school zones a citation is issued for 6 miles over and roadways it is 9 miles over. No one can do whatever they want. An officer can still stop you.
