# Summary of Meeting:

Fire Chief James Pantalone: Average volume of calls is up in the low twenties. It has involved accidents, medical emergencies and service calls. Employees have done an incredible job. At this pace we are 200 calls over last year which puts us over 4,000 calls for the year.

Police Chief Nick Roberts: Commend the officers on a great job that they did last Friday evening when we had an incident on Shafer Drive. Detectives were out immediately and had three suspects in custody within an hour.

Public Works Director David McCann: Have worked on getting East Market Street ready for the July 4<sup>th</sup> celebration. We have been repair catch basins before the 2018 Paving Program begins. Will start doing skim paving at the end of July.

Zoning Administrator Peter Ross: We are at the half year mark and have issued 115 permits at an estimated value of \$11,004,078.

Trustee Rick Clark: Would like to recognize Beth Carmichael from Trumbull County Tourism Bureau as the new Executive director. She has been officially on the job for a month.

Resident Gus Killias, 9044 Briarbrook: This is in regards to a house at 4057 Adrian that was a total loss from a fire. The remainder of the structure has been demolished. I am requesting permission from the Trustees to keep three items on the property. One is the cement driveway. The second item is a shed and the third is a fence in the backyard. All are in good shape.

Trustee Clark: We are in agreement that the driveway could remain. The demolition permit has 45 days remaining and if the property is sold and the purchaser wants the shed and fence, we will allow that to remain. After the permit expires the shed and fence will have to be taken down because of home rule regulations regarding demolition.
