Summary of Meeting:

I would like to thank the fire department, road department, trustees and Nick R. administrator for the excellent 4th of July parade. Everything went smooth as always. No mishaps that we know of and everyone did a great job.

Dave M. Last year we put in a request thru the planning commission for a critical infrastructure grant for the Morgandale area. We were successful in getting that grant. It will allow us to do a number of improvements in that area. This will impact 5 streets, Basswood, Elmwood, Beachwood, Thornwood and Ashwood. The drainage over there has been deplorable. This project is going to allow us to improve the drainage and improve some of the streets. It's a total cost project of \$500,000. \$450,000 is construction and \$50,000 for design and inspection. This project should start the early part of August. The bid opening is 7/16 and will take 3 weeks to evaluate them.

- Dan M. Over the last 30 days, zoning has approved 23 permits with an estimated value of \$680,000. Fees collected amounted to \$3,818. Currently we are evaluating 89 properties for property maintenance violations.
- Our budget is nearing ground zero this year. We are doing all we can to maintain. We have seen a cumulative loss of \$300,000 funding thru the with-drawl of the TPP tax. We've seen cumulative decreases of millage and valuations which all impacts our budget. The department continues to see a rising call volume at an alarming rate. For nearly a decade we have taken our position as the busiest department in Trumbull County averaging almost 27% above the next closest department in call volume. The last 3 years alone, we have seen at least a 12% increase. We have seen an increase of 300 call volume annually. The Bolindale station is staffed with part time employees. That area in itself has gone up 80%. We are asking that you consider that approval and placing a 2.25 mill levy on the ballot in November. We believe the use of these funds will go to 3 items. We need to add a 4th ambulance in this township. We need to increase staff at our Bolindale area. We need to maintain service delivery across the entire township. We would appreciate your support of a 2.25 mil levy in November.

Rick What would happen if we don't have this levy or if it failed?

Jim P. certainly decreased service delivery. Bolindale area is where we have seen this largest jump. It is suffering without adequate response. There may be calls that we cannot get to. We may have to rely on neighboring communities at a certain point.

Ed Palumbo -201 Sanctuary

This is just the first reading on the levy? I think you should have heard from the public first. All the time I have been coming here I have not heard about a station that is not fully maned. Why didn't we hear about this station closing before?

- Jim P. In the fall of 2017 it was brought to light that what we were doing was adding on part time individual to try to target partially opening up Bolindale station. It is open 7 days a week from 7:00 AM to 4:00 PM.
- Ed I think you should have put the levy on last year but since the school board levy was on at the same time you didn't want to compete against them. You wanted to let that pass first and then come back for this one.

Rick I'm missing you point Ed.

Ed You could have put that on the ballot but didn't want to compete with the school board levy.

Rick I don't think that is correct, but what if it was? I don't understand what the difference would be.

Ed

The difference is that if you needed it now you needed it then. You're looking at more equipment down the road. You're saying property values are going down. What is that saying? Everything can't keep going the way it is. You can't keep going after more money and more money because you'll end up with is a list of houses where the grass needs cut. I keep saying you can't keep taxing people beyond their ability to pay that tax does not make a community better.

Darlene

That was our argument to the State of Ohio. We called the governor's office to make a plea where they have billions of dollars in the rainy day fund and they keep taking away all the money from the local governments. Their answer was that you go to the residents if they want services.

The overall tax rate in Howland Township is still less than most of the surrounding communities. We are at 13.5 for township services, if you look at Kinsman they pay 17 and if you look at Liberty, it is the highest in the State of Ohio at 20. Howland Township has historically worked very hard to not go to the taxpayers until we absolutely determine that it is a necessity. We have cut corners, lived within our means and live within our budgets as possible. It is our last resort to go to the taxpayers and give them a choice.

Rick

We are not raising taxes. Going forward now we are going to the voter and try and convince them the plight of the fire department to the voting residents of Howland Township and hope they support us. It is up to them whether these taxes get raised.
