WHEREAS, this Board finds, determines, and declares that the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Howland Township, which is located exclusively in Trumbull County, Ohio.

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of Howland Township, Trumbull County, Ohio, two-thirds of all members elected thereto concurring, being Resolution No. 2022-077, that it is necessary to levy an additional tax in excess of the ten mill limitation for the benefit of and upon the entire territory of said Howland Township, pursuant to Ohio Revised Code §§ 5705.03, 5705.19(J), and 5705.191, for the purpose of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, for the payment of salaries of permanent or part-time police, communications, or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.33 of the Revised Code, for the payment of the costs incurred by townships as a result of contracts made with other political subdivisions in order to obtain police protection, for the provision of ambulance or emergency medical services operated by a police department, or for the payment of other related costs, at a rate not exceeding 1.50 mills for each one dollar of valuation, which amounts to \$0.15 for each one hundred dollars of valuation, for a continuing period of time, commencing in 2022, first due in calendar year 2023.

BE IT RESOLVED that the Fiscal Officer of this Board of Trustees of Howland Township be and he is hereby directed to certify a copy of this Resolution to the County Auditor with the request that said County Auditor certify to this Township Board of Trustees the total current tax valuation of this Township and the dollar amount of revenue that would be generated by a specific number of mills, namely 1.50 mills.

It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with law.

BE IT FURTHER RESOLVED, in accordance with Ohio Revised Code §§ 5705.03, 5705.19(J), and 5705.191, that the provisions of said tax levy be submitted to the electors of the entire territory of said Howland Township, in the general election to be held on the 8th day of November, 2022

WHEREAS, the following list of properties have been cited during the month of June, 2022 in violation of the Howland Township Resolution 2003-58 (Abatement, Control or

Removal of Vegetation, Garbage, Refuse or Other Debris), and Howland Township Resolution 2002-93 (Establish Fines) where the yards have not been maintained; and

WHEREAS, Howland Township has received complaints from neighbors of said properties that the condition interferes with the reasonable enjoyment of use of the property and high grass and/or garbage, refuse or debris poses a safety and health threat to the neighborhood. The unsightly appearance of the properties is detrimental to the aesthetic value of the neighborhood and would cause a depreciation of property values; and

WHEREAS, the Zoning Office has not heard from any of the property owners, by telephone or mail.

WHEREAS, At least seven days before providing for the abatement, control, or removal of any vegetation, garbage, refuse, or other debris, the board of township trustees shall notify the owner of the land and any holders of liens of record upon the land that the owner is ordered to abate, control, or remove the vegetation, garbage, refuse, or other debris, the owner's maintenance of which has been determined by the board to be a nuisance.

WHEREAS, if that vegetation, garbage, refuse, or other debris is not abated, controlled, or removed, or if provision for its abatement, control, or removal is not made, within seven days, the board shall provide for the abatement, control, or removal, and any expenses incurred by the board in performing that task shall be entered upon the tax duplicate and become a lien upon the land from the date of entry.

NOW THEREFORE, BE IT RESOLVED that Howland Township declares and finds the following properties to be a nuisance.

### REPORTS FROM THE DEPARTMENT HEADS:

Trustee Matt Vansuch: Food Truck Friday June 3 went well. The next one will be on July 1. Farmers Market has started and continues each Saturday from 9:00am to 1:00pm at the Richard E. Orwig Park. Forms for the upcoming July 4 parade are on the township's website.

Trustee Dr. Jim LaPolla: Food Truck Friday had a good attendance.

Trustee Rick Clark: The Yellow House will be moved on Sunday July 24, 2022 beginning at 6:30am., and preparation for both sites will start soon. Dr. LaPolla recognized Jason Altobelli for donating the house to the Howland Historical Society.

Asst Fire Chief Sapp: Changing the software in the department for reporting that reports to the state for all fires and EMS runs.

Asst Police Chief Urso: Updated the implementation of the department's new body cameras.

Administrator Darlene St. George: Thanked the Police Department for the township's Shred Day. They collected about 5,051 lbs. of paper to shred and collected food and donations for the Bolindale Food Pantry.

Public Works Director David McCann: After the storms they are working on picking up branches. Residents have to call for them to come and pick them up. They are also spending a lot of time maintaining the cemetery.

Zoning Director Dan Morgan: Working on property maintenance. Had 84 complaints and 74 are still open. Issued 44 new permits valued at \$947,000 of improvements. One permit was for a new home.

Fiscal Officer Tom Krispinsky: Spoke on how the increase of fuel prices has an effect on the budgets for all the township departments.

#### **PUBLIC COMMENTS**

Jason Altobelli, developer for Muirfield Estates, expressed post-construction concerns regarding additional storm water regulations.

Julie Altawil asked how someone could apply for summer help jobs in the township.

Bill Ponko from Allenwood, Surrey Hill, had complaints on a neighbor having trash in his yard. What can he do about it? Rick Clark told him to contact Dan Morgan. He also has a concern about flooding and draining in the Bellwood and Allenwood area. David McCann told him that the township is planning on placing a catch basin in the area to help with the excess water.

Harry Pacifizo from Bellwood, Surrey Hill, had complaints that neighbors' down spouts drain onto their yards and this causes flooding problems. Rick Clark told him that is not a township responsibility because it is private property. Dan Morgan mention that there is a brochure out in the lobby that address this issue.

Charles Leightner, from Surrey Hill questioned who is responsible for the island there. David McCann told him that is in the township's right of way. He had another question on placing signs there, and Dan Morgan told him that only political and free speech signs are allowed. He then went over a list of objectives and questions regarding the formation of a Surrey Hill improvement committee.

Ed Palombo had questions on agenda items #11 and #13. For item #11 the amount was \$13,000 and on item #13 the Township is only replacing one ambulance. After reviewing all options, the township decided to purchase a new ambulance versus replacing the engine on the old one.
