# RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS OF THE QUESTION OF LEVYING A TAX IN EXCESS OF THE TEN MILL LIMITATION

WHEREAS, on June 8, 2022, this Board adopted Resolution No. 2022-077 determining to submit to the electors of the entire territory of Howland Township, which is located exclusively in Trumbull County, Ohio, the question of levying an additional tax in excess of the ten-mill limitation, as described below, a copy of which Resolution was certified to the Auditor of Trumbull County; and

WHEREAS, that the County Auditor has certified to the Board that the dollar amount of revenue that would be generated by 1.50 mills for each one dollar of total current tax valuation of Howland Township, which amounts to \$0.15 for each one hundred dollars of valuation, as set forth in said Resolution, is the annual amount of \$686,278.00.

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of Howland Township, Trumbull County, Ohio, two-thirds of all members elected thereto concurring, being Resolution No. 2022-092, that this Board determines to proceed with the submission to the electors at the general election to be held on November 8, 2022, pursuant to Ohio Revised Code §§ 5705.03, §5705.19(J), and §5705.191, of the question of levying an additional tax in excess of the ten mill limitation for the benefit of and upon the entire territory of Howland Township, for the purpose of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, for the payment of salaries of permanent or part-time police, communications, or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.33 of the Revised Code, for the payment of the costs incurred by townships as a result of contracts made with other political subdivisions in order to obtain police protection, for the provision of ambulance or emergency medical services operated by a police department, or for the payment of other related costs, at an annual tax rate of 1.50 mills for each one dollar of valuation, which amounts to \$0.15 for each one-hundred dollars of valuation, in order to raise the amount of \$686,278.00 each year for a continuing period of time, commencing in 2022, first due in calendar year 2023.

**BE IT RESOLVED** that the Fiscal Officer of this Board of Trustees of Howland Township is authorized and he is hereby directed to certify immediately a copy of this Resolution and the prior Resolution and Certificate of the County Auditor referred to in the Preamble hereto to the Board of Elections, Trumbull County, Ohio on or before 4:00 P.M. (E.S.T.), August 10, 2022, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with law.

**BE IT RESOLVED** that the provisions of said tax levy be submitted to the electors of the entire territory of said Howland Township, at the general election to be held on the 8th day of November, 2022;

Be It Resolved by the Township Trustees of Howland Township

WHEREAS, the following list of properties have been cited during the month of July, 2022 in violation of the Howland Township Resolution 2003-58 (Abatement, Control or Removal of Vegetation, Garbage, Refuse or Other Debris), and Howland Township Resolution 2002-93 (Establish Fines) where the yards have not been maintained; and

WHEREAS, Howland Township has received complaints from neighbors of said properties that the condition interferes with the reasonable enjoyment of use of the property and high grass and/or garbage, refuse or debris poses a safety and health threat to the neighborhood. The unsightly appearance of the properties is detrimental to the aesthetic value of the neighborhood and would cause a depreciation of property values; and

WHEREAS, the Zoning Office has not heard from any of the property owners, by telephone or mail.

WHEREAS, At least seven days before providing for the abatement, control, or removal of any vegetation, garbage, refuse, or other debris, the board of township trustees shall notify the owner of the land and any holders of liens of record upon the land that the owner is ordered to abate, control, or remove the vegetation, garbage, refuse, or other debris, the owner's maintenance of which has been determined by the board to be a nuisance.

WHEREAS, if that vegetation, garbage, refuse, or other debris is not abated, controlled, or removed, or if provision for its abatement, control, or removal is not made, within seven days, the board shall provide for the abatement, control, or removal, and any expenses incurred by the board in performing that task shall be entered upon the tax duplicate and become a lien upon the land from the date of entry.

NOW THEREFORE, BE IT RESOLVED that Howland Township declares and finds the following properties to be a nuisance.
