CHAIR RICK CLARK GAVE THE OATH OF OFFICE TO DANIEL W. EBERT

REPORTS FROM THE DEPARTMENT HEADS:

Trustee Matt Vansuch: Spoke about his meeting with the Trumbull County Emergency Management Advisory Board prior to our meeting.

Trustee Rick Clark: Administrator Darlene St. George and myself met with the SCOPE administrative staff about issues dealing with the building. We'll be meeting with them more often.

This past year we qualified for rebates and credits from Ohio Bureau of Workers Compensation. We want to thank the employees for practicing good safety procedures.

Curbside pickup of live, undecorated Christmas trees will take place through January. Due to David McCann absence could not be here tonight and he wanted to let the residents know that they are still picking up Christmas trees.

Fire Chief Pantalone: The Department finished the year strong. We had the most calls in the county. We have been keeping all three stations open since COVID-19 started.

Police Chief Roberts: The Department handled 9,790 calls during the year. Included in these calls were 979 traffic stops, 385 criminal traffic citations, 1,373 incident reports, 650 crashes, 218 arrests, 33 overdoses and 145 towed vehicles.

Planning Director Kim Mascarella: We have issued a demolition permit for the Ponderosa Steakhouse on Elm Rd.

The Famers Markets are on the 1st and 3rd Saturday of the month at the SCOPE building. We had the 3rd best year of sales in 2022. We are planning on having four Food Truck Friday events this summer.

Bruce Gump questioned the high number of calls in the Fire Department. Chief Pantalone said that EMS runs are also included in this figure and Rt 46 and Shepherd of the Valley being in the township is another reason.
