REPORTS FROM DEPARTMENT HEADS:

Trustee Matt Vansuch: The Annexation hearing for May 22 was dismissed, refiled and rescheduled for July 17, 2023. Tom Krispinsky will represent the Township's elected officials at the Howland Community Scholarship breakfast on April 25, 2023. The July 4th activities will be posted soon. You'll be able to go to our website to sign up to be in the parade. The Bolindale Food Pantry with Pastor Mackey, has been in operation for 11 years and needs financial help. Therefore, this is a call out to our community to help them out financially if you can.

Trustee Dr. Jim LaPolla: This is a reminder that the branch pickup for the township is as follows: The Eastside start April 17 and the Westside, May 1. We do not trim any trees. Ohio Edison has certain procedures that they follow on which trees get trimmed and when they do them. I would like to thank all of our departments for the great job they did during the storms that came through the past 2 weekends.

Assistant Fire Chief Pace: With the two storms we had we responded to 60 calls for the first one and 40 calls with the second one. A reminder the if you have any wires down because of the storm please don't touch or otherwise try to move or pickup. Call the Fire Department or Ohio Edison. With the warm weather a reminder about our ban on open burning. The ban is from 6:00 AM till 6:00 PM.

Police Chief Roberts: To help stock the Food Pantry, just a reminder that our Shred & Fill the Cruiser day is May 6 between 10 AM - 1 PM at the Howland SCOPE Center.

Public Works Director David McCann: With the storms we had a few of our roads closed due to downed trees. Within the week we had all the roads open and the township's roads cleaned up. With the nice weather we have started our catch basin projects. This also means that we have started grass cutting. At our cemetery we had a lot for funerals this past winter and during the first storm a big tree came down but did not damage any tombstones.

Planning Director Kim Mascarella: Still working on our Comprehensive Plan. Our next public forum will be May 17, 2023 at 5:00 PM in the conference room. The Zoning Department has issued over \$1,000,000 in permits. The summer Farmers Market will begin on June 3, 2023. Food Truck Friday will be on the 3rd Friday of each month during the summer.

PUBLIC COMMENTS:

Chuck Mackey, Director of the Bolindale Food Pantry remarked about the change in the area since 1948. He thanked the Township for all its help for the Food Pantry.

Mark Groom, a Howland High School student, did a presentation on why explaining the benefits from the township to put sidewalks on Rt 46. This would encourage biking that would be for the health and safety our residents.
