Be It Resolved by the Township Trustees of Howland Township

WHEREAS, the following list of properties have been cited during the month of September 2023 in violation of the Howland Township Resolution 2003-58 (Abatement, Controlor Removal of Vegetation, Garbage, Refuse or Other Debris), and Howland Township Resolution 2002-93 (Establish Fines) where the yards have not been maintained; and

WHEREAS, Howland Township has received complaints from neighbors of said properties that the condition interferes with the reasonable enjoyment of use of the property and high grass and/or garbage, refuse or debris poses a safety and health threat to the neighborhood. The unsightly appearance of the properties is detrimental to the aesthetic value of the neighborhood and would cause a depreciation of property values; and

WHEREAS, the Zoning Office has contacted the property owner, and the property owner does not have the ability to dispose of the rubbish in a timely fashion.

WHEREAS, At least seven days before providing for the abatement, control, or removal of any vegetation, garbage, refuse, or other debris, the board of township trustees shall

notify the owner of the land and any holders of liens of record upon the land that the owner is ordered to abate, control, or remove the vegetation, garbage, refuse, or other debris, the owner's maintenance of which has been determined by the board to be a nuisance.

WHEREAS, if that vegetation, garbage, refuse, or other debris is not abated, controlled, or removed, or if provision for its abatement, control, or removal is not made, within seven days, the board in performing that task shall be entered upon the tax duplicate and become a lien upon the land from the date of entry.

NOW THEREFORE, BE IT RESOLVED that Howland Township declares and finds the following properties to be a nuisance.

REPORTS FROM DEPARTMENT HEADS:

Trustee Matt Vansuch: Reminded residents to sign up for emergency notifications offered by the Trumbull County Emergency Management System. It lets residents know of emergencies by text, phone, or email. There will be a storm assessment form that residents can fill out online.

Trustee Dr. James LaPolla: Absentee voting will start soon and reminded residents that there is an opening for Mr. Clark's position since he is retiring.

Trustee Rick Clark: A Zoning Commission Meeting will be held on September 20 at 5:00 p.m. He suggested that residents of the Crosswinds area attend if they have concerns about their properties.

Administrator Darlene St. George: This Friday, September 15, will be the last Food Truck Friday for the year. It will be from 6:00 p.m. to 9:00 p.m.

Fire Chief Pantalone: The department has been working with Trumbull County Emergency Management Agency and John Hickey, and residents can sign up to get alerts by either text, voicemail, or email. Mr. Hickey gave a presentation on how the system works. The department is preparing for the Diverging Diamond Interchange (DDI) and how it will affect the response time for the department.

Police Chief Roberts: The department is also preparing for the DDI project by having two police cars on the south side and two on the north side of Rt 82 when there are four police cars on the road. The department had a meeting with ODOT today, and in October, Rt 46 will be closed for four days to take down one bridge and again in Spring 2024 to take the other bridge down.

Public Works Director David McCann: The Township's paving program is about 90% completed. The road construction signs that are still up will be taken down when everything is complete for each project. The Township's Limb and Branch pick-up project will start on October 23 for the east side of Mosquito Creek and November 6 for the west side.

Zoning Director Dan Morgan: The last Food Truck Friday will be this Friday, September 15. The Zoning Department issued 17 building permits and 72 violations since last month's meeting. The department now has 121 cases still open. In the past month, the department handled 166 inspections. The Zoning Commission Meeting will be on Wednesday, September 20, at 5:00 p.m. to discuss the Township Community Comprehensive Plan. The North Road Recycling Center is now open from 7:00 a.m. to 7:00 p.m., as security cameras and new fencing were installed.

COMMENTS FROM PUBLIC:

Chuck Morrow from Crosswinds wondered why the bathrooms in the Administration building are closed to the public and what determines East and West for the Township.

The bathrooms were closed for COVID-19, and the Mosquito Creek distinguishes the East and West for the Township.

Carmella Neilson from Castillion asked if the Township could help her with flooding from the creek next to her property.

She was told that the creek is on Park property and the Township cannot go on her private property.
