Trustee Frank Dillon: Congratulations to Ray Pace on becoming the new Fire Chief.

Administrator James Pantalone: We held the first Department Head meeting this week. Everything is going smoothly with all departments. It's been a busy few weeks with the transition.

Fire Chief Ray Pace: I would like to thank everyone for giving me this opportunity to be the Township's Fire Chief. With the weather breaking you'll see more trucks on the road working on fire hydrants.

Police Chief Nick Roberts: I have nothing to report this month. I congratulate Ray on becoming Fire Chief.

Public Works Director David McCann: The spring season is here, and we started mowing grass this past week. The Limb and Branch pickup will start on the Eastside on April 15 and on the Westside on April 29.

Zoning Director Dan Morgan: We issued 28 permits totaling \$2,642,000 in valuation in March. As of now, we have 111 complaints still open. With it being spring, there will be more coming. There will be a rezoning meeting on April 17, 2024, for a property on Niles-Cortland Rd SE, which would convert from a CRD 1 to 2.

Fiscal Officer Tom Krispinsky: Explained the revenue the township received from the state from cigarette taxes collected.
