

Permanent Sign Fact Sheet

Is a zoning permit required for a permanent sign?

Yes, a zoning permit is required for all permanent signs in all zoning districts. A zoning permit is also required when changes are being proposed to existing permanent signs, including sign face replacement. If the existing sign is not in compliance with current regulations, then you will be asked to bring the sign into compliance before making any changes. Zoning permits are issued by Howland Township.

What are the permanent sign guidelines?

There are two types of permanent signs permitted in the Township: ground-mounted and wall signs. The maximum size of a permanent sign depends on your property's zoning and the number of businesses it contains. Please call the Zoning Department to find out your zoning district.

Internal Lighting of Signs

Internally lighted signs shall consist of light lettering or symbols on a dark or opaque background.

<u>Is Landscaping Required?</u>

Yes, Landscaping is required for new freestanding signs. The following landscaping elements, at a minimum, shall be installed and maintained at the base of every permanent freestanding sign:

- A ground area adjacent to the base of the sign, equal to at least the sign area, shall be covered with mulch or groundcover plants (such as ivy, pachysandra, or the like).
- At least one (1) deciduous shrub and one (1) evergreen shrub shall be installed, in the adjacent ground area, for each ten (10) square feet of sign area. Shrubs shall be selected which have a mature height of not less than two (2) feet.

What types of permanent signs are prohibited?

Signs that employ parts or elements that revolve, rotate, whirl, spin, or otherwise make use of motion to attract attention are prohibited. Roof-mounted signs, festoons, pennants, posters, ribbons, streamers, spinners, and lighted signs are all prohibited. Additionally, temporary signs cannot be posted on telephone or traffic poles, nor can they be placed in a location that may obstruct the sight path of any motorist.

Setback, height, and size requirements
